This addendum becomes part of the Proposal Documents and modifies, as noted below, the original Bidding Documents.

WRITTEN RESPONES – QUESTIONS AND ANSWERS

QUESTION 1. Section 6.2.2, Subsection 6.2.2.10 – Please detail the Cerner connectivity requirements.

RESPONSE: **The UNMH would like to have a system that can interface with Cerner for documentation purposes.**

QUESTION 2. Section 6.2.2, Subsection 6.2.2.11 – Please detail the dynamic documentation requirements.

RESPONSE: **The UNNMH is asking for the ability to AdHoc or narrative chart easily as often as Q5-15 min.**

QUESTION 3. Section V, Scope of Work – Will UNMH be contracting for a Project Manager to represent the UNMH side of the project?

RESPONSE: **A UNMH project manager will be assigned to the project.**

QUESTION 4. Exhibit K, Training – how many staff and of what type, does UNMH expect the successful bidder to train? Will these staff be performing the monitoring after go-live?

RESPONSE: **The UNMH will need training from the bidder for 10-15 staff members at the time of implementation.**

QUESTION 5. How many patient observation beds to you have monitored during a peak period?

RESPONSE: **Sixteen (16).**

- QUESTION 6.** How many one to one sitters are employed by the University of New Mexico Hospitals for patient monitoring?
RESPONSE: **Variable**
- QUESTION 7.** Would the University of New Mexico Hospitals prefer all mobile cameras (secured to a cart), all fixed in-room cameras, or a combination of the both? If a combination – how many fixed cameras and how many fixed in-room cameras.
RESPONSE: **All mobile**
- QUESTION 8.** Whether companies from Outside USA can apply for this? (like, from India or Canada)
RESPONSE: **Yes**
- QUESTION 9.** Whether we need to come over there for meetings?
RESPONSE: **Yes, Finalist may be invited for oral presentations and demonstrations at UNMH’s sole discretion at a date and time to be determined. Also, Offeror would need to fulfill Section V. Scope of Work, which may require an Offeror to attend meetings at the UNMH.**
- QUESTION 10.** Can we perform the tasks (related to RFP) outside USA? (like, from India or Canada)
RESPONSE: **No, if the UNMH data leaves the United States, it is in the hands of entities that, by definition, are not covered by HIPAA. Under the Affordable Care Act/Medicare Advantage, the UNMH is prohibited from offshoring. In addition, there are Export Control Act implications to offshoring. The UNMH requires that all data remain within the Continental United States, at all times.**
- QUESTION 11.** Can we submit the proposals via email?
RESPONSE: **No, electronic version/copy can NOT be email. Please see section 4. Organization of Proposals for more information**
