UNMH Response to Question 1: Yes, the GEO Access Reports can be excluded from the 60 page limit.

Question 2: If our company does not qualify for Veteran (Exhibit A) or Small Business (Exhibit C) would UNMH still like the exhibits included in our response? UNMH Response to Question 2: Yes, Please include all attachments in your response.

Question 3: Under 4.6 page 13 it states that UNMH does not require the bidder from doing Exhibit F. should the bidder complete it or not?

UNMH Response to Question 3: The vendor does not need to fill out Exhibit F when submitting the proposal, however, UNMH may ask the vendor at a later time to fill out Exhibit F during the RFP process.

Question 4: UNMH would like only ASO rates and not fully insured? **UNMH Response to Question 4:** Please submit ASO Rates.

Question 5: Will you be granting an extension given that the question/answer period has been extended?

UNMH Response to Question 5: At this time, the Proposal due date will remain April 7, 2017.

Question 6: Would the University of New Mexico Hospitals (UNMH) be interested in receiving a fully insured Dental quote as an alternative to the current self-funded arrangement? If so, how should we include the pricing for this on the Cost Exhibit?

UNMH Response to Question 6: Not at this time.

Question 7: Please provide a current Summary Plan Description document or Dental certificate that would provide frequency limitations and detailed plan limitations?

UNMH Response to Question 7: This document is not available; however, the plan includes standard types of provisions.

Question 8: Are monthly Explanation of Benefit (EOB) counts available for Calendar Year 2015 & 2016?
