To all of our valued industry partners,

In conjunction with the New Mexico Pharmacists Association's annual meeting, we are asking for monetary donations or raffle prizes to raise money for the New Mexico Pharmaceutical Care Foundation and the UNM College of Pharmacy.

The purpose of the New Mexico Pharmaceutical Care Foundation: "The specific objectives and purposes of this corporation shall be to provide resources for pharmacy education, research, projects in pharmaceutical care and disease management, education for pharmacists, pharmacy technicians and the public, and community screening and public health projects related to pharmaceutical care."



Activities overview:

1. Participating Pharmacists and Student Pharmacists from the University of New Mexico College of Pharmacy provide medication review programs at events around the state. In past years this has included the Annual New Mexico Senior Olympics, the Annual Seniors Program at Glorieta, Prime Time Expo, City of Albuquerque Employees Health Fair, etc. These programs are arranged in cooperation with the New Mexico Aging and Long Term Services Department (formerly Agency on Aging).
2. The Foundation manages a NM Department of Health grant to provide "Tobacco Cessation" through community pharmacies around the state of New Mexico. The grant is in its fourth year. The program provides education about cessation counseling to the pharmacists and pharmacy technicians. Pharmacists provide the counseling and necessary medications to patients in more than ten communities.
3. The Foundation supports pharmacist education through funding the UNM College of Pharmacy Student Scholarship Fund. Funding comes from the annual Golf Tournament - none of the tournament funds are used for funding the Pharmacists Association. Two thirds of the Tournament proceeds are donated to the UNM COP to assist Student participation at national pharmacy meetings and to provide two UNM COP Scholarships. One third is retained by the NM Pharmaceutical Care Foundation for other program funding.

The mission of the UNM College of Pharmacy is to develop innovative leaders in pharmaceutical care and research who enhance the quality of life for the people of New Mexico.

The Scholarship Fund receives an annual contribution from the NMPCF to support scholarship programs at the UNM College of Pharmacy. The annual contribution to the UNM COP funds has consistently been approximately \$10,000 per year.
