COVID-19 Bivalent Boosters

COVID-19 boosters are available in New Mexico. The vaccine rollout for Pfizer BIVALENT 12+ and Moderna BIVALENT 18+ started on September 1. You can check if and when to get COVID-19 boosters with the CDC's COVID-19 booster tool. https://www.cdc.gov/ coronavirus/2019-ncov/ vaccines/stay-up-to-date. html#when-you-can-get-booster

The updated COVID-19 boosters add Omicron BA.4 and BA.5 spike protein components to the mRNA COVID-19 vaccine composition, increasing protection against the currently circulating variants.

Effective August 31, the FDA announced Monovalent mRNA

COVID-19 vaccines are **no longer** authorized for use as boosters in people ages 12 years and older. Monovalent mRNA COVID-19 vaccines are to be used as primary doses only.

Here's a frequently asked question that often comes up.

- **Q:** Is it safe to give the bivalent COVID-19 booster the same day as a flu shot?
- A: A wealth of evidence from routine vaccines—plus recent evidence from several studies specifically on COVID-19 and flu indicates they are safe to give at the same visit on

the same day at different injection sites. This practice is recommended by CDC and its Advisory Committee on Immunizations Practices (ACIP).

The COVID-19 Booster Bivalents for children aged 5-11 years are in the planning steps for a Mid-October rollout. CDC has released the Fall Vaccination Operational Planning Guide for this preparation. Got Shots 2022 Summary

This year's Got Shots events took place from July 9 through August 31 to allow even more time for parents to get their children up to date. Schools in Southern NM started extra early this year, so we pushed the starting date back to allow more time before school got underway.

Seventy-four providers from across the state participated this year, representing 26 of our 33 counties. With just over half of the providers reporting numbers, clinics saw over 2,044 children and administered over 4,990 shots. Approximately 10% of the children were ages 0-2, about 26% were ages 3-6, and 63% were ages 7-18.

The NM Primary Care Association, NMDOH, NMIC and our managed care partners, BCBSNM, Presbyterian and Western Sky Community Care, donated incentives for the children getting immunized. Incentives included scholastic books, coloring books and crayons, pencils, rubber ducks and stickers. We appreciate all who participated in making this year's Got Shots events a success!

She helped her company establish vaccination clinics, coordinated staffing for clinics from the initial vaccination authorizations through current clinics. She worked to have mobile clinics in operation. Amy even travelled to homes to vaccinate homebound seniors. Amy is the reason Pharmacy Technicians were authorized to administer vaccinations in NM. She is the primary trainer for both pharmacists prescribing are aware of the immunization sites and options. What is monkeypox?

Monkeypox is a viral zoonotic disease, meaning that it can spread from animals to humans. It can also spread between people.

Why the name monkeypox?

It was first identified in colonies of monkeys kept for research in 1958.

It was only later detected in humans in 1970.

What do I do if I think I have monkeypox?

- Isolate yourself
- · Avoid close contact with others
- Clean hands regularly
- Contact your healthcare provider for advice, testing, and treatment.

There are no treatments specifically for monkeypox virus infections. But monkeypox and smallpox viruses are similar, so antiviral drugs and vaccines developed to protect against smallpox may be used to prevent and treat monkeypox virus infections.
