Voices for Children

## Dear VFC Provider.

This summer, we ask you once again to join "Got Shots" in catching children up on their needed regular vaccines.

We will hold our annual "Got Shots" campaign from June 14 through August 30. We invite you to sign up now to participate as a Got Shots provider for your community.

Many children will need immunizations for school. We encourage your clinic to participate in Got Shots. To do that, we ask you to consider the following:

- Hold your Got Shots clinic on one or more of the days during June 14-August **30**, preferably during evening or weekend hours to accommodate working parents;
- See any child who presents for immunizations without an appointment, regardless of whether they are a patient or whether they have insurance;
- Bill insurance for the administration fee reimbursement, but during your event, we ask that you immunize all children at no cost to the parent, including copays;
- Complete timely data-entry of all vaccines into NMSIIS; •
- Make sure to order extra vaccine to cover your special events-when you order, be sure to let the VFC program know that you will be participating in Got Shots!
- Follow all CDC and AAP guidance for safe clinic practices.

Posters will be available on our website for download to help your clinic advertise and announce your dates and times of participation. NMDOH and community partners will be helping to advertise using radio and tv ads and social media posts.

We plan to provide a bag of incentives for you to give out to your patients 0-18, as per usual. To plan for sufficient bags of incentives, we ask that you register by May 8. If you will be traveling to ABQ and can pick up your bag any time after that, please let us know.

Please join the New Mexico Department of Health, the New Mexico Primary Care Association, and the New Mexico Immunization Coalition, along with our managed care partners, Presbyterian Healthcare Services and Blue Cross and Blue Shield of New Mexico, in making sure that all New Mexico's children are immunized on time!

Be sure to fill out the attached registration form and return by Thursday, May 8. Thanks in advance for your participation! Please contact any of us if you have questions.
