## Services Provided in New Mexico

#### Supported Living, Residential and Day Services

- Offered in Bernalillo, Cibola, McKinley and San Juan counties
- Supported Living Services
  - Offers homemaking, personal care, respite and mentorship support

#### Residential Services

- Over 40 group homes in Albuquerque and Farmington
- Staffing levels vary depending on needs of individuals in the home
- All person-centered care with collaboration with PT, OT, SLP and/or behavioral therapy
- WiFi is a supported therapy on the Waiver due to COVID

#### Day Services

- Most individuals live in their own homes or assisted living facilities
- Provide 1:1 support in the community, including with employment
- Due to COVID, 1:1 support provided in the home or remotely

Family, Infant and Toddler (FIT) Program

Home-based supports to families with 0-3 year

olds who are at risk for developmental delays

Developmental screenings, including

Comprehensive developmental

Early intervention services which offer:

Specialized instruction

Service coordination

Speech therapy

hearing

evaluations

Offered in McKinley County, including Zuni Pueblo

# Family Living Services

- Offered in Cibola and San Juan counties
- Individual lives with a family or caregiver that is not their parent, guardian or spouse
- Support provided to access community, ADLs and appointments within a family environment.

Behavior Management Crisis Support

- Offered only in Bernalillo County
- Crisis provider as part of Developmental Disabilities Behavior Management Program
- Staff specifically trained in handling crisis
