Marta E. Wosińska, PhD

Deputy Director, Duke-Margolis Center for Health Policy; Washington, DC



Marta E. Wosińska, PhD, is Consulting Professor and Deputy Director for Policy at the Duke-Margolis Center for Health Policy. Widely recognized as an expert on health policy, economics and regulation, Dr. Wosińska leads the Center's Washington, DC office.

Dr. Wosińska's experience spans both academia as well as the Executive and Legislative branches of the government. In 2019 Dr. Wosińska served as an economic advisor to the U.S. Senate Finance Committee, providing drug market analysis and expert guidance for the Committee's bipartisan investigative and

legislative work on drug pricing. Dr. Wosińska also served for over three years as Chief Healthcare Economist in the office of Inspector General (OIG) at the US Department of Health and Human Services.

Prior to OIG, Dr. Wosińska had a seven-year tenure at the US Food and Drug Administration (FDA) where she headed the Economics Staff at the office of Strategic Programs in the Center for Drug Evaluation and Research and served as Senior Economic Advisor to FDA's Deputy Commissioner for Medical Products and Tobacco, in both roles advising senior FDA leadership on a wide range of economic issues related to drugs and biologics.

Before entering public service, Dr. Wosińska was an Assistant Professor of Marketing at the Harvard Business School, where her academic research focused on prescription drug marketing. She also was a visiting Assistant Professor at the Columbia Business School, where she developed and taught courses in Healthcare Marketing and Marketing of Pharmaceuticals and Medical Devices. Dr. Wosińska received her PhD in economics from University of California at Berkeley and a bachelor's degree from Arizona State University.

Mr. Lebovits is the CEO of his own import and wholesale shoe company, with his primary distribution to small businesses. Mr. Lebovitz has focused on helping people in the community with complex medical issues gain access to the best possible medical care regardless of their financial abilities.

In March of 2020, Mr. Lebovits began working with physicians on the Convalescent Plasma Project. Working with this great coalition, Mr. Lebovits has set out to raise awareness about the potential benefits of treating

COVID-19 patients at the early on-set of the disease with convalescent plasma.

In addition to his work with the Convalescent Plasma Project, Lebovits co-founded the COVID Plasma Initiative in April of 2020. The COVID Plasma Initiative is a volunteer-run organization that focuses on educating individuals and patients on the potential benefits of using plasma and antibodies to treat COVID-19 early on in the disease and where they can seek treatment.

Alongside his co-founding of the Convalescent Plasma Initiative, Mr. Lebovits is a founding member of The Fight is in Us, an international coalition working to maximize the understanding of the individual and societal benefits of COVID-19 Convalescent Plasma in order to accelerate the development of potentially life-saving therapies.
