## SECTION I. SPECIFICATIONS 1.1. Specifications

The University of New Mexico Hospitals ("UNMH") is soliciting for information from a qualitied vendor to provide cafeteria services inside UNM's Comprehensive Cancer Center. As a result of reviewing the information submitted, it is anticipated that UNMH will set a reasonable timeline for the next phase of the procurement process.

#### Introduction:

The mission of the University of New Mexico Comprehensive Cancer Center (UNMCCC) is to assure that *all* New Mexicans have access to world-class cancer diagnosis and treatment and benefit from the latest advances in cancer research. In 2003, the New Mexico state legislature designated the UNM Comprehensive Cancer Center as the Official Cancer Center of New Mexico. In 2005, the Center first received recognition as one of the nation's pre-eminent National Cancer Institute (NCI) designated Cancer Centers. In 2015, the UNM Cancer Center was designated a comprehensive cancer center by the NCI, bringing significant federal funding to our state for cancer research, education and training, community outreach programs, and access for *all* New Mexicans to the most advanced cancer treatments through clinical trials. UNMCCC is located at 1201 Camino de Salud NE, Albuquerque, NM.

The UNMCCC Café consists of two levels. The primary level, located on the 1st floor (2,989 gross sq. ft.) will consist of eating/seating space, coffee bar and final prep kitchen. A demonstration kitchen has been designed to accommodate nutritional seminars to be conducted outside of hours of operation by UNMCCC and external staff. In addition, an exterior patio area will accommodate more seating as well as a secondary entrance to the Café space. The primary level is served by the Ground floor area via a service stairwell and elevator. The secondary level, located on the Ground floor (1,312 gross sq. ft.) consists of dry storage, cold prep area, primary refrigerators and freezers, dishwashing and dish storage, refuse room, Café Manager's office, and Café staff restroom. The grand total for both areas will be approximately 4,301 gross square feet.

There are five hospitals included within the UNM Hospital System: UNM Hospital (UNMH), Carrie Tingley Children's Hospital (CTH), Children's Psychiatric Center (CPC), UNM Psychiatric Center (UNMPC), Sandoval Regional Medical Center (SRMC). UNM Hospitals (UNMH, CTH, CPC, UNMPC) are located as part of the Main UNMHS campus.
