- 1) Provide a quote for the current plan design.
- 2) Provide cost impact for plan design changes, as outlined on cost exhibits
- 3) For Fully Insured, quote on the current contributions, and 3-tier rate structure basis. ASO fees must be quoted on a PEPM basis.
- 4) Use the 80th percentile for U&C.
- 5) Premiums must be guaranteed for a minimum of two (2) years with level rates for Years 1, 2 and 3 (i.e., there can be no increase in rates in Years 2 and 3).

Three-year rate guarantees are preferred.

6) Rates and fees must be **NET** of commissions.
