Please use this document to help us identify our patients. We admit patients from the below locations if the provider is on this list, so please ask the patient who their PCP is and check the middle column.

## Some common scenarios:

1. Patient admitted to IM in past, now has new FM PCP **and has established care:** admit to Family Medicine.
2. Patient admitted by FM in past, now has new non-FM affiliated PCP, or PCP is no longer on the list: Patient should NOT be admitted to Family Medicine
3. Patient of provider who has left the Family Medicine department (removed from list) and hasn't established with new PCP: (or if can't provide information at time of admission), we will admit **up to 3 years** from their last hospital stay or clinic visit.
4. If a patient has an upcoming appointment with a Family Medicine provider **but has not yet established** with that provider:
  - If previous admissions at UNMH to the Internal Medicine Service → IM
  - If no previous admission to Internal Medicine → FM

## Other notes

Unaffiliated FM Providers: We do not admit Family Medicine or Family NP patients who are not on this list. We do not admit for all FM providers in the city/state. There are also Allied Practice Providers (APPs) with “Internal Medicine” or “Family Medicine” in their Powerchart electronic signatures, where those designations are no longer correct. This admitting document lists the APPs currently affiliated with our department.

## The process:

1. **Ask the patient their PCP**
2. If not helpful, look in Powerchart at clinic notes. (Note: First Choice, IHS and HCH do not use Powerchart)
3. Sometimes helpful: looking at who is **writing outpatient prescriptions**, or **whom outpatient consultants say requested the consult** in notes.
4. Patients sometimes know their clinics by location (see above).
5. If unable to ascertain the PCP using these methods, we will admit patients that we have admitted up to 3 years from a previous admission or clinic visit.

\*providers listed with an asterisk are APPs at 1209, who sometimes see walk-ins for either IM or FM providers, so please ascertain the actual PCP if possible. We do admit primary care patients of all the APPs listed on this page.
