### Suggestions for Identifying PCP:

1. **Ask the patient their PCP and/or Clinic**
2. Look in Powerchart at clinic notes. (Note, “Community Partners” do not use Powerchart)
3. Looking **who is writing outpatient prescriptions, or whom outpatient consultants say requested the consult** in notes.
4. Patients sometimes know their clinics by location (see above).
5. UNM Attendings/APPs will have “Internal Medicine” or “Family Medicine” in their Powerchart Electronic signatures

### Some common scenarios:

1. **Patient admitted to IM in past, now has new FM PCP and has established care:** admit to Family Medicine.
2. **Patient admitted by FM in past, now has new non-FM affiliated PCP, or PCP is no longer on the list:** Patient should NOT be admitted to Family Medicine
3. **Patient of provider who has left the Family Medicine department (removed from list) and hasn't established with new PCP:** we will admit **up to 3 years** from their last hospital stay or clinic visit.
4. If a patient has an upcoming appointment with a FM provider **but has not yet established** with that provider:
  - If previous admissions at UNMH to Internal Medicine, admit to IM
  - If no previous admission to Internal Medicine, admit to FM
5. **If patient is currently on Hospice, but has either been admitted to FM, or seen FM provider in Clinic, with the past 3 years:** admit to Family Medicine
6. **Patients who receive addiction services at ASAP and have been referred to UNMH ER for inpatient Benzodiazepine or ETOH withdrawal:** Admit to Family Medicine
7. **Patients who are admitted to either FM or IM for Census Overflow** should always go back to their original services on future admissions regardless of who wrote the DC summary.
8. **Family Medicine Providers not on this list (aka not at UNM or one of the Community Partner clinics):** Admit to Internal Medicine
9. **Patient seen by Family Medicine Providers covering the Post-Discharge Clinic:** Admit to FM only if the patient has established with the FM provider in the provider's own clinic
10. **Pediatrics Specific Information:**
  - Less than 2 months: Admit to FM MCH
  - 2 months-18 years: admit to FM IPS per FM-Peds Services Line Agreement (See UNM FM Wiki)
  - Peds pts who reach age 18: Even MRN's go to FM, odd MRNs go to IM
  - After age 19 if no PCP, admit to IM
  - Adolescents (14 years old up to 18th birthday) with a **primary** admitting diagnosis of substance use disorder will all be admitted to FM regardless of PCP
