Annually, Lobos from across the state converge at the state capital to partake in UNM Day at the Legislature. Occurring annually at the New Mexico State Legislature, UNM Day features Lobos of every program, department, and college of the university.

Throughout the entire day, student pharmacists rotated between providing health screenings and walking the rotunda handing out leaflets in support of House Bill 42 (Pharmaceutical Services Reimbursement Parity).

At every turn within the capitol, student pharmacists donning their white coats were visible advocating for their profession. At every stage of their Doctor of Pharmacy program, student pharmacists from the UNM College of Pharmacy are encouraged to leverage their influence to advance the profession of pharmacy, as well as provide a voice to those underserved communities that benefit most from their care. UNM Day allowed them to demonstrate the tremendous value they currently have as students, and offered a glimpse into their budding potential as health champions for the state of New Mexico as full-fledged pharmacists.












ew Mexico, much like the rest of the country, is experiencing an immense shortage of health care providers. The effects of this shortage are felt most strongly in the rural and underserved areas of the state. The pharmacists of New Mexico. on account of being the most accessible yet underutilized health care providers, are a wonderful option for expanding access to care, which quickly became a goal for the New Mexico 2020 legislative session. Pre-filed in December 2019, House Bill 42 (Pharmaceutical Service Reimbursement Parity) was introduced into the 2020 New Mexico Legislative session with hopes to increase patient access to care across the state.

The bill was the result of a robust collaboration between the New Mexico Pharmacists Association, the New Mexico Society of Health-System Pharmacists, the UNM College of Pharmacy, and many New Mexico pharmacists. Sponsored by House Representative Deborah A. Armstrong,

chair of the House Health & Human
Services Committee, the bill garnered
great bipartisan support. Charged with
mandating equal reimbursement for the
clinical services provided by advanced
practice pharmacists, the bill proved to be
an incredible force in redefining the role of
pharmacists serving New Mexico.

Under House Bill 42, pharmacists with prescriptive authority as well as pharmacist clinicians will receive reimbursement from

NM Medicaid and commercial insurance plans at the same rate as other health care providers. In New Mexico, pharmacists with prescriptive authority must undergo supplemental training covering the areas of in-depth patient assessment, thorough clinical decision-making, and the development of evidence-based, patient-oriented treatment plans. With training in the appropriate protocols, pharmacists with prescriptive authority can provide immunizations, tobacco



cessation, tuberculin skin tests, naloxone, and hormonal contraception to patients in their communities.

Established by the state legislature greater than 25 years ago, pharmacist clinicians have a larger scope of practice, including the ability to prescribe medications, order laboratories, perform physical examinations and manage acute and chronic conditions according to a protocol approved by the New Mexico Boards of Pharmacy and Medicine. Pharmacist clinicians require even further training including a 60-hour physical assessment course and a 150 hour patientcontact preceptorship before advanced licensure. With the approval and signing of House Bill 42, pharmacist clinicians now also have the ability to be reimbursed by NM Medicaid (pending approval of a CMS-waiver) and commercial insurance plans for the clinical services they provide. This will allow for more opportunities for pharmacist clinicians to work outside the metro areas and offer their services to

rural and underserved communities, providing chronic disease and medication management to treat a variety of conditions such as diabetes, hypertension, and pain, as well as different populations such as geriatric and pediatric patients. This reformed reimbursement process introduced with House Bill 42 will be a tremendous benefit to not only patients, but other providers as one physician, Jeremy Snyder points out, "I can't imagine our busy outpatient clinic running without having pharmacist clinicians."


On February 20, 2020, House Bill 42 unanimously passed the Senate without debate and was signed by Governor Michelle Lujan-Grisham on March 6th... The passage of this bill was largely in thanks to the College of Pharmacy faculty, students, dean, support staff, and many others who made countless phone calls, emails, and were present at the Capitol to have their voices heard. Dean Donald A. Godwin expressed his gratitude and summed up the victory, "the passage of this bill will echo throughout the country and I will make sure to let every Dean of a College/ School of Pharmacy know what we have done here in New Mexico. I cannot wait to see where pharmacy in this state goes next." In fact, the passing indeed made the national spotlight via an email blast from the American Society of Health-System Pharmacists


(ASHP) that summarized the historic event, "ASHP is grateful to all of the individuals and organizations that took the time to express their support for the bill, which represents a significant step in expanding access to healthcare in New Mexico. We congratulate and thank the NMSHP and the UNM College of Pharmacy SSHP for their work on this issue and look forward to continuing our advocacy efforts on expanding pharmacists' scope of practice in other states."

House Bill 42 and legislation preceding it, showcase how the evolution of the profession of pharmacy can address the health care disparities facing New Mexicans every day. Until all of the state's pharmacists are practicing at the top of their license, there will be a need for the important advocacy work that the College, as well as its affiliates, does. Bills like House Bill 42 keep New Mexico at the forefront of pharmacy practice around the country. Outside of the state Capitol, the UNM College of Pharmacy does its part to prepare the pharmacists of tomorrow by providing its graduates with prescriptive authority training and opportunities to become full-fledged pharmacist clinicians. Every patient deserves access to an advanced practice pharmacist to optimize his or her healthcare and HB 42 is a step in the right direction towards achieving this goal.











he clock strikes 8:00 am and the health care team at Truman Health Services Clinic readies for another day of serving New Mexicans living with HIV. Among the health care team is UNM College of Pharmacy faculty and alumna, Kelsea Aragon. As the college's newest faculty member, she represents the cutting-edge of advanced practice pharmacy in New Mexico—the pharmacist clinician (PhC).

As a pharmacist clinician, Kelsea's role at Truman Health transcends the pharmacy and places her at the center of patient care, where she and other members of the health care team tirelessly pursue the best possible outcomes for their patients. Whether prescribing medications, performing physical exams, or ordering lab tests, Kelsea proudly does her part to ensure that her patients can achieve an undetectable HIV viral load while maintaining a strong immune system. Today, 250 of New Mexico's 1,800 pharmacists are practicing advanced

pharmacy as pharmacist clinicians, redefining what it means to be a pharmacist.


Although clinical pharmacy have seemingly always been an essential part of the continuum of health care, it was not until 1993 that pharmacists were able to embody the contemporary, advanced practice pharmacist. With the shortage of primary care providers state-wide. New Mexico introduced and passed the Pharmacist Prescriptive Authority Act, allowing specialty trained pharmacists to provide care to patients under collaborative agreements with supervising physicians.

Pharmacist clinicians like Kelsea have had a tremendous impact on the health of their patients throughout New Mexico and around the country, addressing disparities in health care access and improving outcomes for patients. Around the state, pharmacist clinicians hope to continue redefining the clinical role of pharmacists in the health care team.














PRECEPTOR SPOTLIGHT MARIA APODACA

JAMES F. ZIMMERMAN AWARD

C. FRANK BENNETT (BSPh '80)

C. Frank Bennett, PhD, is the chief scientific officer at, and founding member of, Ionis Pharmaceuticals. He is responsible for the advancement of antisense technology and expanding Ionis' drug discovery platform. Bennett is also the franchise leader for neurological programs at Ionis. He has been involved int he development of antisense oligonucleotides as therapeutic agents, including research on the application of oligonucleotides for inflammatory, neurological programs at Ionis and Cancer, oligonucleotide delivery, pharmacokinetics and medicinal chemistry.

Bennett is a co-recipient of the 2019 Breakthrough Prize in Life Sciences for his contributions to the discovery and development of Spinraza (nusinersen) and the 2018 Hereditary Disease Foundation's Leslie Gehry Brenner Prize for Innovation in Science for his leadership and continued commitment to developing antisense therapies for Huntington's disease.

He has published more than 230 papers on antisense research and development, and he is an inventor on more than 175 issued patents.
