DIRECTOR'S MESSAGE

2024-2025 (FY25) marked a year of growth, advocacy, and meaningful public health impact for the New Mexico Poison and Drug Information Center. From federal engagement to expanded state partnerships, we strengthened our role as both a local and national voice in poison prevention and response.

We had the privilege of hosting Representative Melanie Stansbury for a site visit at our center. During her visit, we showcased our call center operations, toxicosurveillance capabilities, and poison prevention outreach efforts. The visit concluded with a thoughtful discussion where the Representative shared her vision for the future of New Mexico on topics, including substance use.

Following the visit, Representative Stansbury became a strong advocate on a longstanding poison center issue of georouting— a critical challenge in which calls to poison centers are misdirected, potentially delaying emergency care. Along with two other members of Congress, she formally urged the Health Resources and Services Administration (HRSA) to take federal action. This event was an inspiring example of how local engagement can drive national advocacy—momentum that was further amplified by the national leadership of Dr. David Gummin, who began his term as President-Elect of America's Poison Centers during this pivotal time.

Alongside these national efforts, we expanded our partnerships and public health initiatives within New Mexico. We collaborated closely with the New Mexico Environment Department (NMED) and the New Mexico Department of Health (NMDOH) to support a statewide response to harmful algal bloom exposures. We also strengthened our partnership with the Cannabis Control Division of the New Mexico Regulation and Licensing Department to improve our joint response to recalls involving contaminated cannabis products.

As you read our FY25 report, you will discover our ongoing efforts in reducing poison-related illness and death for all New Mexicans. You will read that our services saved an estimated \$10.5 million in healthcare costs this year—a conservative figure given rising hospital expenses and inflation. You will additionally learn that nearly 30% of our managed cases originated from rural areas. Our report also highlights other impactful initiatives including our research aimed at promoting drug safety and addressing drug shortages, our public and media outreach efforts, and our student and community education.

Our efforts would not be possible without the continued support of our parent organization, the College of Pharmacy at the University of New Mexico Health Sciences Center, UNM Children's Hospital, our previously mentioned public health partners, and other key stakeholders. We are also deeply grateful to the Governor, the Legislature, and staff from the Higher Education Department, Department of Finance and Administration, and Legislative Finance Committee for their continued support of our poison center as well as our supporters from the Federal level.

With that, I invite you to explore our report.

ABOUT OUR SERVICES

The New Mexico Poison and Drug Information Center (NMPDIC) helps manage exposures to any toxic substance.



The NMPDIC proudly serves all New Mexicans. Our telephone services are **free**, **confidential**, **and offered in over 80 languages**.



Pharmacists specially trained in poison information answer the phones. We have 12 registered pharmacists (10 certified) and one pharmacy technician.




We took **19,187 cases** in FY 25. We safely managed **10,032 (80.1%) cases** on-site, with an **estimated savings of \$10.5 million** in healthcare dollars.



The NMPDIC is available 24 hours a day, 7 days a week.
The peak call time is between 6 pm and 10 pm.






In FY 25, **84.8**% were human exposure calls, **4.2**% were animal exposures, **4.9**% drug information calls, and **2.2**% other information.



In FY 25, we received calls from all **33** counties: **71%** Urban, **27%** Rural, and **2%** Unknown.

HOT TOPICS

Recreational Cannabis

Recreational adult use of cannabis became legal in NM in 2022. Edible cannabis ingestion exposures in children <5 years old decreased to 33 calls as compared to 43 calls in 2024. Increased awareness about the dangers of edibles in children, focused on prevention, is a priority during public outreach events.

Semaglutide

Semaglutide and the risks surrounding compounded products featured heavily in national news in 2024. The NMPDIC received 16 calls in 2024 from patients with exposures to semaglutide, with more than half of those patients requiring medical evaluation. Our pharmacists are highly trained and equipped with the expertise to not only identify and manage adverse drug reactions but also to effectively intervene in cases of overdose, ensuring patient safety and optimal therapeutic outcomes.

Environmental Gases

Our pharmacists expertly handle exposures to environmental gases, responding to a variety of incidents. In 2024, we managed 339 calls related to carbon monoxide, 134 calls for chlorine gas exposure, and 15 calls for hydrogen sulfide incidents. Through our response and expertise, we ensure the safety and well-being of individuals exposed to these hazardous gases.

Kratom

Kratom is sometimes used illicitly for its stimulant and sedative effects, often to self-manage pain, anxiety, or withdrawal symptoms, despite potential risks. The NMPDIC managed 10 patients in 2024, with 6 experiencing significant adverse effects from kratom use, highlighting the importance of monitoring and addressing the potential risks of its use.
