SKIIP 2018-19 School Kids Influenza Immunization Project

MIC and DOH are gearing up for this year's SKIIP— School Kids Influenza Immunization Project. This year 380 schools statewide have registered to participate. Vaccine has not yet arrived but we anticipate that SKIIP clinics will begin Mid-October and run through January.

For the third year in a row, SKIIP will be providing injectible flu vaccine only. ACIP met in February and voted to recommend FluMist to be one of the vaccine options once again. However, NMDOH and SKIIP had already placed their flu vaccine order prior to the ACIP meeting. Therefore, SKIIP will again only offer injectable flu vaccine.

Also new this year, based on recommendations from the CDC-Department of Health-sponsored

evaluation of SKIIP, it was decided to concentrate SKIIP efforts on elementary and middle schools. Some highperforming high-schools have been grandfathered in but will be phased out next year.

SKIIP consent packets are

Training has been updated for the 2018-19 flu season and SKIIP trainers are available in all five public health regions. All medical personnel who participate in SKIIP

are required to complete the

training. The SKIIP training provides 2.4 nursing CEUs. An online version of the training is available if school nurses are unable to attend an in-person training. SKIIP volunteers must register with the NM Medical Reserve Corps. to ensure background checks are done and volunteers have active licenses.



National Immunization Survey 2017 Teen Data Update

National Immunization Survey Teen data were released in August, showing both the New Mexico and the nation-wide Human Papillomavirus (HPV) vaccine up-to-date coverage levels rising to 46.0% for 13-15-year-olds. While HPV coverage gains have been consistent, they remain significantly lower than the Healthy People 2020 Target of 80%.

As a confidential repository of immunization records for all New Mexicans, NMSIIS does so much more than track immunization schedules for the citizens in our state. it also integrates data from birth and death records, health care providers and parents records.

Join NIPA HPV vaccination learning

The National Improvement Partnership Network and the Academic Pediatric Association are collaborating on a national initiative. NIPA, starting in November 2018, funded by the CDC, to recruit health care practices that serve adolescents to participate in a 9-month, virtual, quality improvement project. Practices that enroll in this multi-state project will receive training in QI methodology and implement evidence-based practice changes to increase immunization rates and reduce missed opportunities for HPV vaccine administration. Participants can earn credit towards professional certifications for project participation:

- MC-FP credit for 1 Part IV module or 20 Part IV points, from the American Board of Family Medicine (ABFM)
- Up to 20 Performance Improvement Continuing Medical Education (CME) credits from the AAFP

Through four consecutive cohorts, NIPA has proven an effect model for getting results. Family medicine physicians from prior project cohorts increased HPV series initiation rates 46-58% and increased series completion rates 13-45%. <u>Enroll</u> by October 15.

The <u>webpage</u> is the result of a collaboration between Dr. Stanley Plotkin, Dorit Rubinstein Reiss, and Heather Bodenstab that offers a repository of vaccine safety references for those asked to address these issues either with their patients or more formally, in court. The website is divided into topics and includes links to related pages. The references, with summaries, are also listed on the pages of the VEC website.
