This updated guide provides easy-to-use information covering "how to" activities to enhance your existing adult immunization services or introduce them into any clinical setting, including:

- Setting up for vaccination services
- · Storing and handling vaccines
- Deciding which people should receive which vaccines
- Administering vaccines
- Documenting vaccinations (including legal issues)
- Understanding financial considerations and billing information

Yellow Fever certification for VFC providers

The Epi Division is responsible for issuing yellow fever certifications to New Mexico providers who want to administer this vaccine.

The point of contact for yellow fever certifications is Laura Gutierrez, 505-827-2155 or Laura.Gutierrez@state.nm.us.

For questions about yellow fever certification or to track down a yellow fever clinic from the number on a yellow fever stamp on a traveler's yellow card, contact Laura. These are the steps for the yellow fever certification process:

- The physician, pharmacist, NP or PA sends the DOH a request to administer yellow fever vaccine (including a copy of their medical/ pharmacy license).
- 2. Epi staff confirms that the clinician's license is active.
- 3. The ERD Director reviews the request to approve or disapprove.
- 4. Once approved, the Epi staff sends Sanofi Pasteur a message letting them know that the provider can order yellow fever vaccine.
- 5. Epi staff sends the requesting provider a letter letting them know they are approved, and have been registered in the CDC's

- website, and enclose a yellow fever pamphlet provided on the CDC's website about the administration of yellow fever vaccine.
- 6. Epi staff also adds the provider to CDC's website for yellow fever vaccination.
- 7. The provider is required to purchase a stamp
- from an office supply store that meets certain specifications. *The stamp is used on the traveler's yellow card.*
- 8. The Epi program issues the provider a number for their stamp.
- 9. The Epi staff maintains a spreadsheet with provider's name, facility, facility address, phone number and fax number.

NMIC Annual Meeting

Over ninety members attended the NMIC's 15th Annual Meeting and Celebration on December 1 in Albuquerque. Dr. Andrew Kroger, Medical Officer with the CDC's National Center on Immunizations and Respiratory Diseases, gave the keynote presentation on the newest vaccines and most recent recommendations for immunizations. In addition, there were presentations on Vaccine Exemptions, NIS data, and Influenza Surveillance, and updates on SKIIP, the VFC program and NMSIIS. The day also included a brief "15 years in review" and a round of Immunization Bingo.

CDC's new online tool for childrens immunizations

n three easy steps, you can create a vaccination schedule for your child age birth through 18 years:

- Enter your child's name and date of birth
- Enter your child's vaccination history and generate a catch-up schedule
- Save the vaccination schedule

Using this tool, you can...





- accelerated schedule that identifies doses and timing of vaccines needed—useful when your child needs to travel, must catch-up on missed doses, or during a disease outbreak.
- Save and update your child's vaccination history on your computer.
- Print a personalized vaccination schedule.

This tool follows the 2017 child and pre-teens/ teens recommended immunization schedules. Your child's medical history and health status can affect the timing and vaccines your child may need. Talk with your child's doctor.

This is a web-based tool. No personal information is saved by CDC or Georgia Tech. Check out the new <u>catch-up childhood and adolescent</u> immunization online tool.
