NMIC Celebrates its Third Anniversary!

n December 2nd, the New Mexico Immunization Coalition held its third anniversary meeting and celebration, and there were certainly many accomplishments to celebrate (see page two).

Over sixty members attended the meeting. Lane Wake, an epidemiologist with Colorado's Immunization Program,

gave a keynote presentation on Colorado's immunization situation and the steps they have undertaken to better understand their low immunization rates. She provided an excellent overview of the data Colorado has collected and their activities to address the low coverage rates.

Over a delicious holiday lunch, we recognized a few people including two outgoing members of the NMIC Steering Committee, Barak Wolff and

Theresa Tsosie Robledo, and Maggie June, Administrative Assistant to the NMIC for her excellent work on the NMIC publications. Dr. Lance Chilton gave a slide presentation on his trip to Sri Lanka, where he recently volunteered to

provide medical assistance to victims of the tsunami. It was a fascinating and enlightening talk with great photos and maps.

After lunch, Dr. Maggi Gallaher gave an overview of New Mexico's pandemic flu plan. The Department of Health held a pandemic planning summit on October 29th during which health care providers and community members provided input for the statewide plan. NM's plan is modeled after the national plan, which has recently been released.

During the afternoon, NMIC subcommittees reported on activities and progress. Steve Nickell and Cleve Bryant gave a demonstration of NMSIIS and explained

the rollout process and timeline. Approximately ten sites will first pilot test the system to work out any kinks. Then other providers will be encouraged to register to be users and receive training. It's very exciting to see the system actually coming into use.

Several mini-grant recipients gave short presentations on the innovative ways they have used their minigrant funds. Karen Sakala reported on the baby photo/baby book project

in La Clinica de la Familia clinics; Kathy Lopez-Bushnell displayed the card swipe machine used to track health care worker flu shots at University Hospital; Marianne Panzini Rosenthal showed the immunization directory published by the Doña Ana County Immunization Coalition. All

NMSIIS Update for Providers

he New Mexico Statewide Immunization Information System (NMSIIS) is nearly ready to go live. Here's what VFC providers need to know to be part of this exciting advance for New Mexico's children. The only equipment required is a computer with internet connection. High-speed connection is preferred although a dial-up connection will work.

NMSIIS will rollout in two phases. Phase I begins this winter with ten or so practices being trained and given access to NMSIIS. In the Spring, other providers and users will be brought on. Experience gained in Phase I will be used to fine-tune the Spring open enrollment and training of providers.

The first step in enrollment is for your

practice to submit the provider survey which is at www.health.state.nm.us/ immunize/Pages/Provider/NMSIIS/ NMSIISsurvey.html The survey can be submitted online, or printed and mailed to NMSIIS staff— address on survey form. VFC providers will receive an enrollment packet by mail or can download enrollment documents. Classroom training sessions will be held across New Mexico beginning next Spring. Each practice will need to one volunteer to coordinate NMSIIS access for their site and train site users. On-site training in provider offices may be available in some cases, and phone help desk assistance will be available to enrolled providers.

Providers will need to submit immunization data to NMSIIS on a timely basis (2-3 weeks after administration) so that information will be available for the next patient visit. Options for submitting data:

- Manual entry of data into NMSIIS using the Web interface— no Part B forms need to be submitted.
- Upload of immunization information data extracts from provider's existing electronic medical record (EMR) or billing data— no Part B forms need to be submitted.
- •Bidirectional data exchange between provider EMR and NMSIIS using HL7 messaging— no Part B forms need to be submitted.
- Submission of completed scannable Part B forms to the DOH for scanning and upload to NMSIIS.

SHOT BRIEFS

Tdap for adults The Advisory Committee on Immunization Practices (ACIP) to the Centers for Disease Control and Prevention recommended that adults receive a booster dose of Tdap in place of the tetanus-diphtheria (Td) booster if they have not received a Td booster dose in ten or more years. Tdap should also be given to adults who will have close contact with an infant less than 12 months of age, ideally at least one month before beginning close contact with infants. In situations where it is important to protect against pertussis, intervals shorter than 10 years since the last Td vaccination may be used. A minimum 2 year interval between Td and Tdap is suggested to reduce the risk of reactions following vaccination. An update to the provisional recommendations for adults just came out. MMRV Quadravalent Vaccine The official ACIP recommendations on the use of the newly licensed measles, mumps, rubella, varicella combination vaccine, ProQuad (Merck) have not been posted yet. MMRV vaccine

is indicated for simultaneous vaccination against measles, mumps, rubella, and varicella among children aged 12 months-12 years; MMRV is not indicated for persons outside of this age group. Use of licensed combination vaccines, such as MMRV vaccine, is preferred over separate injection of equivalent component vaccines as it can reduce the number of injections when administered to children aged 1-12 years for whom (1) the first dose of MMR and varicella vaccines is indicated and (2) the second dose of MMR and either the first or second dose (e.g., during a varicella outbreak) of varicella vaccine are indicated. MMRV vaccine is administered subcutaneously as a single 0.5-mL dose. MMRV must be stored in the freezer (like varicella vaccine). For more information, consult the package insert at www.fda.gov/ cber/label/mmrvmer090605LB.pdf. The New Mexico VFC program expects to be able to provide Proquad in the coming months. A contract is currently being negotiated with the manufacturer and the CDC.

Hepatitis A Vaccine The ACIP has lowered the age for administering Hepatitis A vaccine from 2 years to 12 months.

Influenza Flu season is underway. New Mexico has recently seen its first cases of flu. The public is encouraged to get influenza vaccine throughout the season, and flu vaccine is still available. Consult the NMRRA web page http://www.nmivc.org/ to locate clinics around New Mexico.
