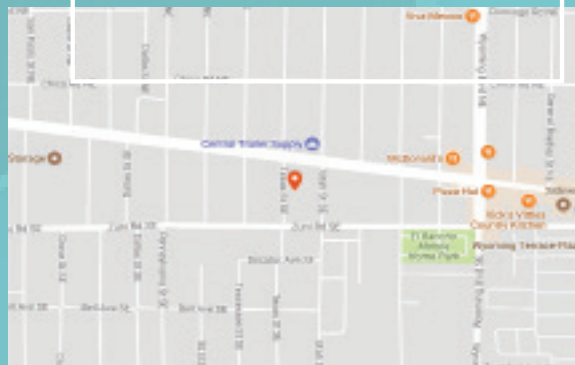


SERVICES WE PROVIDE:

PRIMARY MEDICAL CARE

Appointments are at the UNM North Valley & UNM Southeast Heights clinics. Primary care treats issues of reproductive health, substance use disorder, acne treatment, sports physicals along with many other issues affecting overall health. ADOBE also offers primary care to family and other supports that play a significant role in the progress of the youth.

PSYCHIATRIC CARE

Appointments occur at the same location and often, during the same visit as the primary care appointment. These appointments are to address issues such as anxiety, depression, attention problems, and any other mental health concerns.

HOME/COMMUNITY BASED NAVIGATORS:

Each referral is assigned a navigator who visits with the family in their home or in their community to assist in social determinant issues. This may include, but is not limited to, assisting you or support system on resume building, job hunting, navigating the social service system or the juvenile justice system.

EDUCATIONAL LIAISON:

Each referral who is interested in an educational pathway is assigned an educational liaison. Their liaison will be the advocate in the various school systems, including higher education, to help ensure the youth has the programs and services they need to help them obtain their educational goals. The liaison also serves as an important link between the schools and our medical team to ensure no adverse effects of medical treatments are hindering school progress.



LAW CLINIC STUDENTS & PROFESSORS:

ADOBE has partnered with the UNM School of Law clinics to provide assistance dealing with issues such as tenant/landlord disputes, utility disputes and immigration issues.
